Re: **Tax Adjustment No. 150; TAXES AND ASSESSMENTS ON GAS SALES NOT INCLUDED IN RATES**

Dear Mrs. Paladino and Mr. Baxter:

Pursuant to Commission Decision Nos. 55707 and 55708, Southwest Gas Corporation submits Adjustment No. 150 to "*Taxes and Assessments on Gas Sales Not Included in Rates*".

The attached adjustment reflects the following tax rate changes effective March 1, 2024:

- Effective **March 1st, 2024**, Town of Sahuarita TPT City Sales Tax will increase from 2% to 4%.
- Effective **March 1st, 2024**, the existing Town of Sahuarita Franchise Fee will offset 2% of the Town's City Sales Tax, which will result in an effective Town of Sahuarita City Sales Tax Rate of 2%.
